# CISCE

## Indian Certificate of Secondary Education Examination (ICSE) Class –X

---

### AWARDS AND CONDITIONS FOR AWARDS:

#### ICSE YEAR 2024 EXAMINATION

(1) Pass Certificates will be awarded to candidates who attain the pass standard in at least *five* subjects, which must include the subject **English**.

Provided that no candidate, except as otherwise exempted by the CISCE, shall be awarded a Pass Certificate unless in addition to fulfilling the conditions above he/she has attained a pass grade in SUPW and Community Service as examined/assessed internally by the School.

(2) **Supplementary Pass Certificates** will be awarded to candidates who have obtained Pass Certificates and who appear in a subsequent examination and attain the *pass* standard in *one* or *more* subjects.

(3) **Statement of Marks** will be issued to all candidates who appeared for the examination.

(4) **Issue of results:** Schools/Candidates can view and print the result online. In addition, the Statement of Marks and Pass Certificates will be sent to Heads of Schools after the declaration of results. The result sheets show the result in the examination as a whole and also indicate the standard reached in each subject taken by grades 1 to 9, 1 being the highest and 9 the lowest. Very Good is indicated by 1 or 2. Grade 3, 4 and 5 indicate a *pass with credit*, 6 or 7 indicate a pass and 8 and 9 a *failure*.

The standard reached in Socially Useful Productive Work and Community Service (internally assessed) will be shown on the Mark Sheet by grades **A, B, C, D** or **E**. **A** being the highest and **E** the lowest; **A, B, C** or **D** indicate a *pass* and **E** a *failure*.

### **PASS CERTIFICATES / SUPPLEMENTARY PASS CERTIFICATES**

*Pass Certificates / Supplementary Pass Certificates/Statement of Marks* will be issued through the Heads of Schools as soon as possible after the publication of results.

Duplicate Pass Certificates/ Supplementary Pass Certificates are not issued, instead a Certifying Statement of Examination Results may be requested for by the Head of the School/Individual with supporting documents, and payment of the prescribed charges online.

Duplicate *Statements of Marks* may be requested for by the Head of the School/ Individual with supporting documents, and on payment of the prescribed charges online.

### ENQUIRIES CONCERNING EXAMINATION RESULTS / RECHECK / RE-EVALUATION OF ANSWER SCRIPTS

(1) All enquiries concerning examination results on behalf of school candidates must be made to the **Chief Executive and Secretary of the CISCE** by the Head of the School concerned only and must reach the **CISCE's Office**, not later than the specified date. Schools are asked to bear in mind that a large number of answer scripts are re-marked before the award.

Enquiries should be restricted to results, which are *significantly* below the standard suggested by the candidate's schoolwork in the subject.

(2) **Recheck:** The accuracy of subject *grades awarded* will be checked on request, in one or more subjects, provided that the Head of the School/candidate forwards the request **online** to the CISCE. These requests must be made not later **than FOUR days from the day of the declaration of results**. Schools / Individuals will be required to pay ₹1,000/- per subject/paper (as prescribed by CISCE from time to time), which shall be made online.

The recheck will be restricted to checking whether all the answers have been marked and that there has been no mistake in the totalling of marks for each question in the subject and transferring the marks correctly on to the first cover page of the answer booklet, and whether the continuation sheets attached to the answer script mentioned by the candidate are intact. No other re-evaluation of the answer script or other work done by the candidate, as part of the examination will be carried out at this stage.

## Indian Certificate of Secondary Education Examination (ICSE) Class –X

---

(i) No candidate, person or organization shall be entitled to claim disclosure or inspection of the answer scripts or copies of it or other documents as these are treated as most confidential by the CISCE.

(ii) The recheck will be carried out by a competent person appointed by the Chief Executive and Secretary of the CISCE.

(iii) On rechecking the scripts if it is found that there is an error, the marks will be revised accordingly.

(iv) The communication regarding the revision of marks, if any, shall be sent online to the Head of the School/candidate.

v) The CISCE will not be responsible for any loss or damage or any inconvenience caused to the candidate, consequent to the revision of marks and no claims in this regard shall be entertained.

(vi) The CISCE shall revise the Statement of Marks and Pass Certificate in respect of such candidates whose results have changed, after the previous Statement of Marks and Pass Certificate have been returned by the Head of the School.

***The decision of the Chief Executive and Secretary of the CISCE on the result of the scrutiny and recheck shall be final.***

---

### ELIGIBILITY CRITERIA FOR RE-EVALUATION

**The candidates who are not satisfied with the recheck results of the subjects for which they had applied for, will be permitted to apply for re-evaluation of their answer scripts of those subjects only.**

#### **(3) Re-evaluation:**

The accuracy of a subject grade awarded will be checked on request, in one or more subjects / papers, provided that the Head of the School / Candidate submits the application online. Applications for re-evaluation must be submitted online and received by CISCE **within 24 hours from the time of the declaration of the Recheck results.** The date of declaration of Recheck results will be notified to all the stakeholders, through the website of CISCE ([www.cisce.org](http://www.cisce.org)).

For each re-evaluation, Candidates through their school/Candidates themselves, will be required to pay ₹1,500/- per subject/paper (as prescribed by CISCE from time to time), which shall be made online. **The charges paid for re-evaluation of answer scripts will be non-refundable.**

**The results of all the Re-evaluation requests received by CISCE will be declared together, through the website of CISCE ([www.cisce.org](http://www.cisce.org)).**

i)The re-evaluation of answer script will be carried out by a competent person appointed by the Chief Executive and Secretary of CISCE.

(ii) **On re-evaluation of the answer scripts by the subject expert, the marks awarded, whether increased or decreased, will be considered as the FINAL marks.**

### Important Points:

(i) No candidate, person or organisation shall be entitled to claim disclosure or inspection of the answer scripts or copies of it and other documents as these are treated as most confidential by CISCE.

(ii) CISCE will not be responsible for any loss or damage, or any inconvenience caused to the candidate, consequent to the revision of marks and no claims in this regard shall be entertained.

(iii) The Statement of Marks / Pass Certificate for the candidates who have applied for Recheck / Re-evaluation, will be released after the result of Re-evaluation is declared. However, the result will be available on DigiLocker.

### (4) Main Weakness Report:

If the Head of a School considers that the results in one subject are *significantly* below reasonable expectation, the **Chief Executive and Secretary** of the CISCE for special notes on the **Main Weaknesses** shown by the work of a few selected candidates from the school. It is necessary to limit such notes to ***only one subject per school on any one occasion of examination and to restrict the enquiry to the work of not more and not less than six candidates*** whose work is *significantly below* the standard as suggested by the candidates' school work in the subject. Applications for special notes must be sent **online** to the CISCE's Office not later than **FOUR days from the day** of the declaration of results. Charges commensurate with the work involved will have to be paid online to the CISCE by the School.

**The charges are ₹10,000/- per paper for the Main Weakness Report.**

### LAST DATE FOR RETAINING ANSWER SCRIPTS

**The CISCE does not undertake to retain answer scripts of candidates beyond 60 days from day of the declaration of results of the main examination.**

### **Compartment Examination:**

ICSE Compartment Examination has been discontinued from the Year 2024.

### **Improvement Examination:**

Candidates who wish to **improve their marks / grade in the same year of the Examination**, may take the **Improvement Examination**.

### **1. Eligibility to appear for the ICSE (Class X) Improvement Examination:**

All candidates who appear for the ICSE Main Examination, are eligible to take the Improvement Examination conducted on the same year of Examination. This will include candidates with any one of the following Results:

- (i) PCA - Pass Certificate Awarded
- (ii) PCNA - Pass Certificate Not Awarded
- (iii) SPCA - Supplementary Pass Certificate Awarded
- (iv) SPCNA- Supplementary Pass Certificate Not Awarded

The candidates whose result is declared as **ABSENT** will **not** be **eligible** for the Improvement Examination.

### **2. Number of Subjects permitted:**

The candidates will be permitted to appear in a maximum of **any two subjects** that they would have enrolled themselves for, in the given year of Examination, for the main Examination. It may please be noted that the candidates who choose to appear for a subject which has more than one paper, (e.g. English / Science / History Civics & Geography) then the candidates, will have the option to choose any one or more papers of the said subject.

### **3. Issue of Results to the candidates who appear for the Improvement Examination:**

The higher of the two marks obtained by the candidate in the two examinations (i.e., the Main Examination vs. the Improvement Examination) will be considered as the final marks.

**Detailed instruction will be sent to the Heads of Schools in due course of time.**

### AWARDS AND CONDITIONS FOR AWARDS:

#### ISC YEAR 2024 EXAMINATION

(1) **Pass Certificates** will be awarded to candidates who attain the *pass* standard in **four** or more subjects which must include the subject **English**. Provided that no candidate, except as otherwise exempted by the CISCE, shall be awarded a Pass Certificate unless in addition to fulfilling the conditions above, the candidate has attained a pass grade in SUPW and Community Service as examined /assessed internally by the School.

(2) **Supplementary Pass Certificates** will be awarded to candidates who have obtained *Pass Certificates* and who appear in a subsequent examination and attain the *pass* standard in **one or more** subjects.

(3) **Statement of Marks** will be issued to all candidates who appear for the Examination.

(4) **Issue of results:** Schools/Individuals can view and print the result online. In addition, the Statement of Marks and Pass Certificates (if applicable) will be sent to Heads of schools (through the convenor) after the declaration of results. The result sheets show the result in the examination as a whole and also indicate the standard reached in each subject taken, **except** Socially Useful Productive Work and Community Service, by grades 1 to 9, 1 being the highest and 9 the lowest. Very Good is indicated by 1 or 2. Grade 3, 4, 5 and 6 indicate a *pass with credit*, 7 or 8 indicates a *pass* and 9 a *failure*.

The standard reached in Socially Useful Productive Work and Community Service (internally assessed) will be shown on the Mark sheet by grades **A, B, C, D** or **E**. **A** being the highest and **E** the lowest. **A, B, C** or **D** indicate a *pass* and **E** a *failure*.

### PASS CERTIFICATES / SUPPLEMENTARY

#### PASS CERTIFICATES

**Pass Certificates / Supplementary Pass Certificates** will be issued through the Heads of Schools as soon as possible after the issue of results.

Duplicates of *Pass Certificates / Supplementary Pass Certificates* are not issued, instead a Certifying Statement of Examination Results may be requested by the Head of the School/ Individual with supporting documents, and on payment of the prescribed charges online.

Duplicate *Statement of Marks* may be requested for online by the Head of the School/ Candidate with supporting documents and on payment of prescribed charges.

---

### ENQUIRIES CONCERNING EXAMINATION RESULTS / RECHECK AND RE-EVALUATION OF ANSWER SCRIPTS

(1) All enquiries concerning examination results must be made online, by the Head of the School or candidate concerned, not later than the specified date. Schools are asked to bear in mind that a large number of answer scripts are reviewed before the award.

Enquiries should be restricted only to results, which are *significantly* below the standard suggested by the candidate's schoolwork in the subject.

(2) **Recheck:** The accuracy of a subject grade awarded will be checked on request, in one or more subjects, provided that the Head of the School/ Candidate submits the application online. Applications for recheck must be submitted online and must be received at CISCE's office not later than **FOUR** days from the day of the declaration of results. For each recheck, Candidates, through their school / Candidates themselves, will be required to pay ₹1,000/- per subject (as prescribed by CISCE from time to time), which shall be made online.

**The recheck will be restricted only to check whether:**

- All the answers have been marked;
- There has been mistake in the totalling of marks for each question in the subject and in transferring the marks correctly onto the first cover page of the answer script;
- The continuation sheets attached to the answer script, as mentioned by the candidate, are intact.

(i)The recheck will be carried out by a competent person appointed by the Chief Executive and Secretary of CISCE.

(ii)On rechecking the scripts, if it is found that there is an error, the marks will be revised accordingly.

(iii)The results of all the Recheck requests received by CISCE will be declared together, within four weeks, through the website of CISCE ([www.cisce.org](http://www.cisce.org)).

### ELIGIBILITY CRITERIA FOR RE-EVALUATION

**The candidates who are not satisfied with the recheck results of the subjects for which they had applied for, will be permitted to apply for re-evaluation of their answer scripts of those subjects only.**

(3) **Re-evaluation:** The accuracy of a subject grade awarded will be checked on request, in one or more subjects, provided the Head of the School/ Candidate submits the application online. Online applications for re-evaluation must be received at CISCE's office on the day (i.e., **within 24 hours**) which will be notified to all the stakeholders, through the website of CISCE ([www.cisce.org](http://www.cisce.org)).

For each re-evaluation, Candidates, through their schools / Candidates themselves, will be required to pay ₹1,500/- per subject (as prescribed by CISCE from time to time), which shall be made online. **The charges paid for re-evaluation of answer scripts will be non-refundable.**

**The results of the all the Re-evaluation requests received by CISCE will be declared together, within three weeks, through the website of CISCE ([www.cisce.org](http://www.cisce.org)).**

- (i) The re-evaluation of answer script will be carried out by a competent person appointed by the Chief Executive and Secretary of CISCE.
  - (ii) On re-evaluation of the answer scripts, the marks awarded, whether increased or decreased, will be considered as the FINAL marks.

Charges commensurate with the work involved will have to be paid online to the CISCE by the School.

**The charges are ₹10,000/- for the Main Weakness Report.**

### LAST DATE FOR RETAINING ANSWER SCRIPTS

**The CISCE does not undertake to retain answer scripts of candidates beyond 60 days from day of the declaration of results of the main examination.**

### **Compartment Examination:**

### **Improvement Examination:**

Candidates who wish to **improve their marks / grade in the same year of the Examination**, may take the **Improvement Examination**.

### **1. Eligibility to appear for the ISC (Class XII) Improvement Examination:**

All candidates who appear for the ISC Year 2024 Main Examination, are eligible to take the Improvement Examination. This will include candidates with any one of the following Results:

- (i) PCA - Pass Certificate Awarded

### **CISCE ALLOTTED EMAIL ADDRESS FOR THE HEAD OF THE SCHOOL AND THE STAFF**

All the Heads of schools are requested to use the CISCE allotted email ids of their school to correspond with CISCE. All the important information/circular/notifications issued by CISCE will be sent only to the CISCE allotted email ids of the school. Communication received from any other email id will not be entertained by CISCE.

For any assistance regarding creating/ renewal of CISCE allotted email id of school, please contact CISCE Help Desk.

### **PERIODIC UPDATES MODULE**

Heads of Schools are requested to update their required details through the Periodic Update Module, through the Careers Portal (<https://careers.cisce.org> → affiliation → Periodic Update). In case, new Principal is appointed, the Periodic Update should be initiated by entering details of new Principal (Name, Qualification, Specimen Signature, Experience, contact details etc.) and submitting it to CISCE for verification and approval.

### **RECHECK OF ANSWER SCRIPTS**

**Recheck** is permitted in **all** subjects at the ICSE and ISC Examinations and must be applied for online. The charge for a recheck per subject/paper is **₹1,000/-**.

### **RE-EVALUATION OF ANSWER SCRIPTS**

Candidates who apply for recheck and are not satisfied with their recheck results, are permitted to apply for Re-Evaluation of the answer scripts in those subjects. A 24 hours window on the day of declaration of recheck result will be made available to apply for the same. The charge for a re-evaluation per subject/paper is ₹1,500/- which is non-refundable.

### DECLARATION OF RESULTS

Heads of Schools are hereby informed that **ICSE/ISC Year 2024** Examination results will *not* be given at the CISCE's Office to any individual. The ICSE and ISC Examination results will be declared online, and the Statement of Marks and Pass Certificates of the schools will be sent to the Conveners only.

Heads of Schools are requested to advise candidates and their parents that they **should not enquire** about results from the CISCE's Office.

### CAREERS PORTAL

The following will be made available on the **CAREERS portal** of the CISCE:

- Information on accessing ICSE / ISC Year 2024 *Examination Results*.
  - Submission of requests by Schools for candidates for *Recheck* of ICSE / ISC Year 2024 Examination.
  - Submission of requests by Schools for candidates (for the eligible candidates) for *Re-evaluation* of ICSE / ISC Year 2024 Examination.
  - Provision of registration for ICSE / ISC 2024 Improvement Examination for desirous candidates.
  - Submission of requests by schools for *grant of eligibility* to candidates applying for admission to Class XI of ISC for the Year 2026 Examination.
  - Confirmation of Entry of candidates **registered** for the ICSE/ISC Year **2025** Examination.

### ADMISSIONS TO CLASSES IX, X, XI AND XII

Heads of Schools are to kindly ensure that **all admissions** to Classes IX and XI in respect of candidates for entry to the ICSE (Class X) Examinations and ISC (Class XII) Examinations are positively regularized by **31st July 2024 for ICSE (Class X)** and **31st August 2024 for ISC (Class XII)**, respectively.

**Kindly note the following:**

1. Direct admissions to Classes X and XII are **not allowed**.
2. As per the Regulations, candidates are required to put in 75% attendance of the total working days in **each** of the academic years i.e. Classes IX & X and Classes XI & XII in respect of the ICSE & ISC Examinations respectively, to be eligible for appearing in the concerned examination.
3. The following documents must be uploaded with the request for **transfer admissions online**:
  - a) **Promotion record** of the candidate
  - b) **Attendance record** of the candidate
  - c) **Transfer Certificate**
  - d) Undertaking by the Head of the admitting school stating that the candidate will study the same subjects as offered by him/her in his/her previous school.
4. **Transfer admissions from one affiliated school to another.** Heads of school must ensure that the school has adequate provision for the teaching and learning of the subjects offered by candidates whom they wish to admit. Additionally, for transfer admission to classes XI and XII the school have the permission to offer subjects for candidate concerned has already been registered for.
5. **No change of subject is permissible.** Candidates are not permitted to change any of the subjects with which they have been registered for the ICSE and ISC Examinations.  
Candidates who desire to change subject(s) after completion of Classes IX or XI would be required to **repeat** Classes IX or XI with the new subject(s).

### MIGRATION CERTIFICATES

1. The Office of the CISCE has decentralised the issue of Migration Certificates in order to facilitate their availability to candidates.

In this connection Heads of Schools may place a bulk order of their requirement of Migration Certificates for candidates who pass the ICSE/ISC-Year 2024 Examination and propose to seek admission for continuing their studies in educational institutions other than in those affiliated to the CISCE.

2. The charge for a Migration Certificate is ₹250/-. The total amount for the Migration Certificates required by a school should be remitted **online** to the CISCE. On receipt of the payment, the Migration Certificates will be dispatched by Registered Post/Courier services from the CISCE's Kolkata office to the Heads of Schools.

**Kindly contact the CISCE's Kolkata office at [kolcisce@cisce.org](mailto:kolcisce@cisce.org) immediately in case of non-receipt of Migration Certificates after 15 days of initiating the transaction.**

3. The Migration Certificates are to be kept in a secure place directly under the charge of the Head of the School.

4. The Heads of Schools are to ensure that the following precautions are taken while processing the issue of Migration Certificates.

(a) Migration Certificates are **issued only to candidates who have been awarded pass certificates at ICSE/ISC Examination.**

(b) A register, **recording the numbers** on the Migration Certificates issued to candidates, is maintained.

(c) The Migration Certificate is **countersigned by the Head of the School** indicating the name of candidate and the school, along with the candidate's UID Number.

(d) The details of the candidates recorded on the Migration Certificate should be identical to the details (spelling of the name etc.) as given in the Admission Card/Statement of Marks/Pass Certificate issued to the candidate by the CISCE.

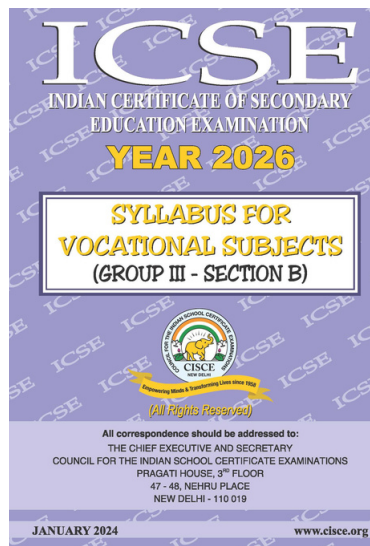


### RELEASE OF REGULATIONS AND SYLLABUSES- 2026

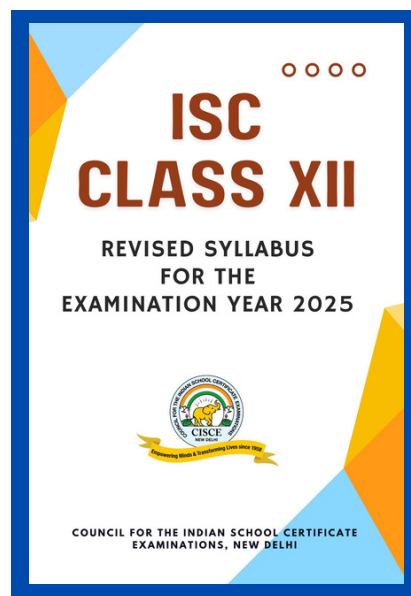


### RELEASE OF REVISED SYLLABUS CLASS XII FOR EXAMINATION YEAR 2025

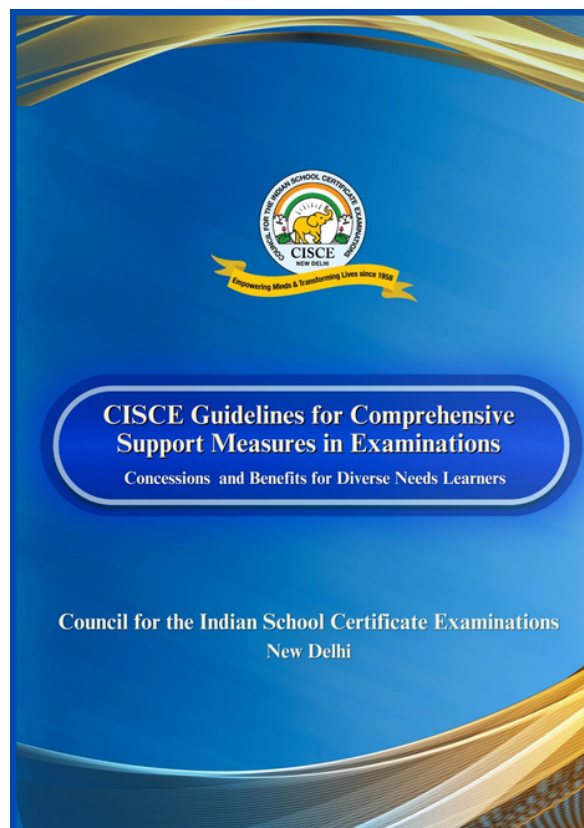

### *Preface*

Henry L.V. Derozio (1809 – 1830) arguably the first Indian Poet, freedom fighter and social reformer was fondly referred to as the “National Bard of Modern India”. He taught English at Hindu College (later Presidency College), Calcutta, and set up a youth movement to promote enlightened living and nationalism. Through his writings he fired the imagination of generation of ‘Derozians’, young people of conviction who were prepared to make any sacrifice for the cause of freedom. *The Harp of India, To India my Native Land and Fakir of Jungheera* are amongst his best known writings.

The ‘Derozio Awards’ are being instituted to celebrate and commemorate the life of this great revolutionary of Anglo-Indian descent, so that his life may inspire a new generation of people to emulate his life and work, in the service of the nation.

### *Objective:*

**The Derozio Awards for exemplary service to school education and human enrichment** have been instituted by the Council for the Indian School Certificate Examinations, New Delhi, to honour and motivate people to serve the nation in a manner that clearly defines leadership in an identified sphere.

### *The Awards seek to:*

- (i) **identify** people who make a difference in their sphere of education;
- (ii) **promote** a sense of achievement, recognition and support for education;
- (iii) **recognise** the work of people for the greater good of humanity;
- (iv) **establish** a role for people to contribute to the nation through education;
- (v) **enable** professionals to use their skill for human enrichment;
- (vi) **generate** concern for the social, physical or cultural ecology of the nation through education;
- (vii) **enhance** global goodwill and understating through the medium of education.

### *Categories of Awards:*

The Awards will be given annually to the following categories:

- (i) Contribution to the society as an Individual.
  - (ii) Contribution to the society as an Institution.

### *Awards:*

Each award will consist of the following:

- (i) An engraved gold medal – 24 grams (22 carats);
- (ii) A citation plaque engraved in silver;
- (iii) A certificate/scroll;
- (iv) An amount of ₹ 1 lac in the form of an account payee cheque.

### *The Jury:*

The Jury shall consist of the following:

- (i) **The Chairman of the Council** for the Indian School Certificate Examinations, shall be ex-officio Chairman of the Jury.
- (ii) **An eminent public servant** or ex-judge of the Supreme Court.
- (iii) **Two eminent educationists** who have established record(s) of service in school education.
- (iv) **A person of eminence**, who has served in the armed forces.
- (v) **The Chief Executive & Secretary of the Council** for the Indian School Certificate Examinations shall be ex-officio Secretary to the Jury.

Note: Appointments of members in categories (ii), (iii) and (iv) will be made by the Executive Committee of CISCE.

### *Procedure:*

The Jury shall establish procedures for selecting the awardees.

The Jury may make recommendations to the Executive Committee of CISCE as it considered best to promote the Awards.

The Jury shall meet once a year to consider the nominations received and make its selection which shall be final and binding.

The Secretary to the Jury shall convene the meeting of the Jury.

---

### **The Process:**

The procedure for application is flexible. Nomination forms are designed to provide basic information. Additional documentation would be called for from shortlisted nominees.

### **Validity of Nominations:**

Nominations received will be considered only for the year in which the application is made.
